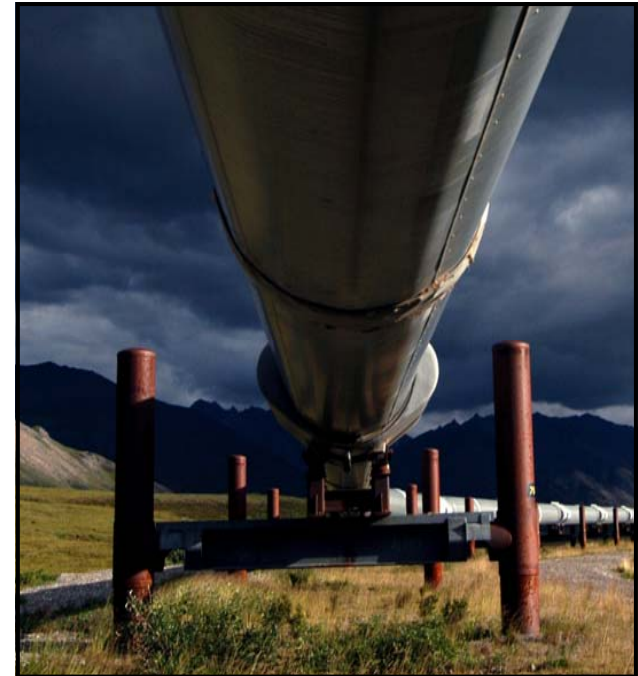

Electronically

- Once you hit submit on the apply button you should receive an acknowledgment that your resume and cover letter were received.
- If a job has already closed the “apply” button will not appear.

If you are unable to submit a resume electronically please e-mail or give us a call and we can work with you to submit your resume by mail or fax.

We accept resumes for **open positions only**. Please be sure to reference the **job number** for the position you are applying for in all documents and in the subject line of your email.

Resume Guidelines

Please submit your résumé as a single document file.

Submit your document in the following formats:

- ⇒ Adobe Acrobat *.pdf files (preferred)
- ⇒ plain text
- ⇒ Microsoft Word 98 (or newer version).

Above noted formats are acceptable. Our system cannot read WordPerfect or Microsoft Works or ClarisWorks file formats.

Always Include your name, address, telephone numbers, and Email address (if applicable) at the top of your resume. (This information will be used to contact you via phone, U.S. Mail, or e-mail.)

- Do not include personal information such as birth date, marital status, height, weight, pictures, social security number, driver’s license number, etc.
- Include the month and year of employment next to each position you have held.
- Include all work history in detail. If you have a degree, list the type and major. Also include certifications and volunteer information, etc. on the resume.

Update your resume! Review the job posting, and tailor your resume for each position to emphasize your experience that is related to the job you’re applying for. If you’re applying for two different positions, have two different resumes handy. **Use a spell checker!**

If you’re in school, note it on your resume. Specify which college or university, the degree you are pursuing, and your expected graduation date. Prepare a cover letter using the example on the back of this brochure as a guideline.

Pre-employment Drug Testing Information

Alyeska Pipeline Service Company (APSC) requires pre-employment drug testing utilizing hair test collections for all positions. The preferred collection site is from the head (approximately 1/2 inch of hair length necessary). Head hair testing provides an approximate 90 day window of detection that checks for illegal drug use. In addition, for Department of Transportation covered positions, APSC will also utilize urinalysis testing. A positive drug test (to include alcohol and marijuana screening) makes you ineligible for APSC employment.

It is important to note that Alyeska does not seek or accept any genetic information as part of the hair testing procedure or any other process that could directly or inadvertently provide genetic information (family medical history).

E-Verify

Federal Law requires all employers to verify identity and employment eligibility of all persons hired to work in the United States. Alyeska Pipeline Service Company participates in E-Verify. E-Verify is an Internet-based system that compares information from an employee's Form I-9, Employment Eligibility Verification, to data from U.S Department of Homeland Security and Social Security Administration records to confirm employment eligibility.
